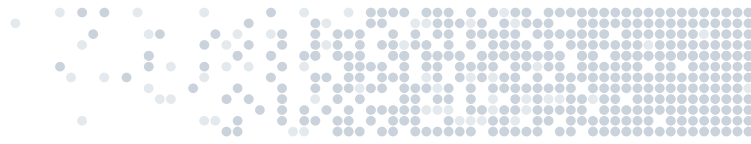

BACKGROUND

The CEO, Mr Saraswat is also the CEO of Executive Security Training Pty Ltd (RTO 40526). The Collingwood location is also the administrative office for Executive Security Training Pty Ltd.

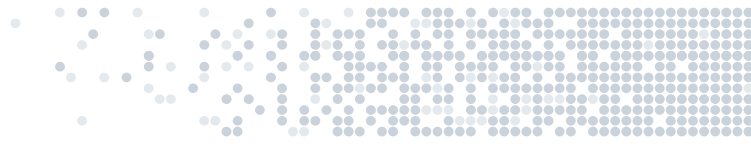
